RESOLUTION ACKNOWLEDGING RECEIPT OF THE MAYOR'S 2024 RECOMMENDED CITY BUDGET AND SETTING THE DATES FOR THE PUBLIC HEARINGS ON THE PROPOSED BUDGET'S ESTIMATES FOR 2024

WHEREAS, pursuant to §C-47 (E)(1) of the Troy City Charter, the Mayor shall file the Mayor's 2024 Budget Message and Recommended 2024 Budget for the City of Troy with the Troy City Clerk no later than October 10, 2023; and

WHEREAS, pursuant §C-47 (F) of the Charter, the City Council shall meet in special session no later than October 15, 2023, to refer the recommended budget to the City Council's Finance Committee, which shall in turn refer the budget recommendations for City Departments to the appropriate standing committees of the City Council to hold preliminary public hearings regarding the portion of the recommended 2024 City Budget applicable to the respective standing committees; and

WHEREAS, pursuant to §C-47 (H) (1) of the Charter, following the preliminary public hearings held by the Finance Committee and the other standing committees, the various committees shall issue reports of their respective hearings to the City Clerk no later than November 15, 2023; and

WHEREAS, pursuant §C-47 (I) of the Charter, after the Council committees file their reports with the Clerk, the Mayor, the Budget Officer, and the City Council shall convene to review suggested changes to the recommended 2024 City Budget; and

WHEREAS, pursuant to §C-47 (J) of the Charter, subsequent to the above meeting, the City Council or the standing Finance Committee shall meet and hold a final public hearing on the budget estimates contained in the proposed 2024 City Budget; and

WHEREAS, pursuant to §C-47 (K) of the Charter, after the final public hearing, the City Council shall hold a special meeting on or before December 1, 2023, or December 2, 2023, if December 1 falls on a Sunday, for the purpose of a passing a resolution to adopt the recommended 2024 City Budget, or to amend and adopt the 2024 recommended City Budget as amended, and to submit the same to the Mayor for approval.

NOW, THEREFORE, BE IT RESOLVED, that the City Council acknowledges the filing and receipt of the Mayor's 2024 Budget Message and recommended 2024 City Budget; and

BE IT FURTHER RESOLVED, that the City Council shall hold a special meeting on Tuesday, October 10, 2023, at 5:30 p.m., to consider the recommended 2024 City Budget and to refer the recommended budget to the Finance Committee, which shall in turn refer the budget recommendations for the City Departments to the appropriate standing committees of the City Council; and





