This project will consist of the complete rehabilitation of both the Dauchy Building and the former Amercian Theater Building.

At the completion of this work the building will become a mixed use project. The upper 3 floor of the Dauchy Building will become from 20-25 residential rental apartments. The first floor of the Dauchy building will become upgraded commercial /retail space.

We have two existing commercial tenants, Troy Tax Service and Berkmayier Travel. In addition we have an executed Letter of Intent with Spot Coffee, a retail food and beverage provider, for an additional 2500 square feet of first floor space. This LOI is being currently being converted to a lease which we expect will be executed shortly with work to begin on tenant fitup this summer.

The American theater will either once again be utilized as theater space, or we may convert it into commercial office/retail use possibly with the addition of a second floor or mezzanine. In either case there is a likelihood that we will create a connection between the Dauchy building and the theater so as to utilize the northernmost structural bay of the Dauchy Building to augment the available footprint of the theater building.
