This project will consist of the partial rehabilitation of the River Triangle Building and complete rehabilitation of the former American Theater Building.

At the completion of this work, the River Triangle Building will be a mixed use building. Floors 1 and 2 will be commercial/retail space and Floors 3 and 4 will be nine residential apartments.

We have nine existing commercial tenants, four on the first floor and five on floors two through four, three of which will all be moving to the upgraded second floor commercial spaces.

The American theater will either once again be utilized as theater space, or we may convert it into commercial office/retail use possibly with the addition of a second floor or mezzanine.




