Household Hazardous Waste includes items or products which can be:

- toxic ☠️
- flammable 🔥
- corrosive ⚠️

and are found in our households. They can include items such as cleaners, gasoline, pesticides, rechargeable batteries, and more.

These products **must** be brought to a household hazardous waste event to properly dispose of them.

The City of Troy typically hosts two events annually at the Troy Resource Management Facility (Alamo) located at the corner of E. Industrial Parkway and Main St. We also collaborate with other municipalities for other events.

While your paint will be accepted at our household hazardous disposal events, you may also bring them to **over 200 retail locations** in New York State. This program is part of PaintCare, a state-wide paint recycling program which began in May of 2022.
